Terms of Service



1. General

- 1. Before using BZEX trading platform services, users should carefully read the entire contents of the "BZEX User Service Agreement" (hereinafter referred to as "this Agreement"), and read and understand the terms of this agreement.
- 2. The user should agree to all the terms of this agreement and follow the prompts on the page to complete all registration procedures. When the user clicks the "register" button during the registration process, the user and BZEX have reached the following agreement and fully accept all the terms under this agreement. This agreement has legal effect between the user and BZEX and has legal binding on both parties force.
- 3. After successful user registration, BZEX will give each user a user account and corresponding password. The user account and password are kept by the user; the user shall be legally responsible for all activities and events carried out with his user account.
- 4. "BZEX User Service Agreement", individual service terms, all activity terms and announcements can be updated at any time by BZEX without prior notice. BZEX reserves the right to modify the above clauses. Once the revised agreement is published, it will effectively replace the original agreement. Users can check the latest agreement at any time. Before using the services provided by BZEX, users should carefully read this agreement and the various service agreements that are inseparable from this agreement. When using related services, users should pay attention to and abide by the relevant provisions applicable to them. If users do not agree to this service agreement

users use BZEX services, they are deemed to have understood and fully agree with the terms of this

agreement and other service terms Contents, including any changes made by BZEX to this agreement and other terms of service at any time, and become BZEX users.

2. User qualification and registration

- 1. The user should be a natural or legal person with full civil rights and civil capacity, or another organization that can independently assume civil liability. If the user does not have the legal capacity qualifications mentioned above, he must obtain the consent of the legal agent or be represented by the legal agent, or be authorized and authorized by the authority to register and trade. Or, although it does not have full civil rights and conduct capabilities, but click the consent registration button, BZEX is deemed to be the operation of the service content such as the registration and completion of the transaction with the consent of its legal agent.
- 2. Before using the network platform service provided by BZEX, users should prepare the following equipment and bear the following expenses:
- 1) Equipped with the necessary equipment for Internet access, including personal computers, modems or other necessary Internet access devices;
- 2) Pay for the telephone charges and network charges related to this service paid by individuals online.
- 3. When the user clicks the "I have read the registration agreement and agree" button, it is deemed that the user agrees to all the terms of this agreement, and has the right and ability to use all services provided by BZEX, such as browsing BZEX platform related information and reasonable transactions. Agree to bear all legal liabilities arising therefrom.
- 4. The user registration and use of BZEX shall not be for the purpose of illegal or disrupting the order of BZEX transactions. The user guarantees that all the information submitted to BZEX is true, accurate and complete. For registration, fraudulent transactions and cheating transactions, if users have the above violations, BZEX has the right to cancel their trading qualifications and rights and interests obtained by participating in trading activities, and stop services and account closure. If the violation causes losses to BZEX, BZEX reserves the right to pursue compensation and bring the case to legal settlement.
- 5. After successful registration, users should properly keep their BZEX platform account and password, change the password regularly or irregularly, and log out of the account in time after each use of BZEX service to ensure account security. The user shall not lend, transfer or use the BZEX platform account for other illegal purposes, otherwise the user shall bear the corresponding legal responsibility if the account is not properly maintained and causes losses.

3. Protection of user personal information

- 1. The BZEX user information referred to in this agreement refers to information that complies with laws, regulations and relevant regulations, and that meets the following scope:
- 1) Personal information provided to BZEX when users register BZEX or apply for BZEX membership card:
- 2) When users use BZEX services, participate in website activities, or visit website pages, BZEX automatically receives and records user browser or mobile client data, including but not limited to IP addresses, information in website cookies, and user request access Of web pages;
- 3) User personal information legally obtained by BZEX from business partners;
- 4) Other users' personal information obtained by BZEX through legal channels.
- 2. BZEX promises: BZEX will not disclose the user's password, name, mobile phone number and other non-public information to any third party without legal reasons or prior permission of the user. And protect the information in the user information that involves the identification of the user's personal identity and the user's personal privacy. It promises that the user's above information will not be disclosed or provided to any third party without the user's permission, except for the following circumstances:
- 1) Disclosure to the user or other third parties with the user's consent;
- 2) With the user's consent to disclose their personal data and enjoy the products and services provided for them;
- 3) According to the relevant provisions of laws and regulations, or the requirements of administrative agencies, disclosure to administrative, judicial agencies or other third parties prescribed by laws;
- 4) Other BZEX disclosures in accordance with laws, regulations and other relevant provisions.

4. Service provision, modification and termination

- 1. Users can check the transactions and related materials published on the BZEX platform, trade specific financial service products and other related activities through the BZEX platform according to this agreement and the relevant usage rules announced by BZEX, and other related activities that BZEX may and may provide in the future service.
- 2. When using the above services provided by BZEX, users should abide by this agreement and BZEX's related rules of use, abide by the principles of voluntariness, equality, fairness and honesty and credibility. The normal order of online transactions.
- 3. While accepting BZEX services, users agree to accept various information services provided by BZEX. The user here authorizes BZEX to send business information to his e-mail, mobile phone, correspondence address, etc. Users have the right to choose not to accept all kinds of information services provided by BZEX, and enter BZEX related pages to make changes.

- 4. BZEX will do its utmost to maintain the normal operation of the platform to provide users with continuous, stable, safe and smooth services. However, the user understands and agrees: BZEX has the right to temporarily interrupt the service when it needs to interrupt the service, such as revising the service page, upgrading the website system, adding service functions, etc.

- 6. Users who have objections to the modification of this agreement or are dissatisfied with BZEX's services can exercise the following rights:
- 1) Stop using BZEX network services;

In this case, BZEX has no obligation to transmit any unprocessed information or unfinished services to users or any third parties that are not directly related.

V. User rights

- 1. The user's username, password and security
- 1) The user has the right to choose whether to become a BZEX member. If the user chooses to become a BZEX registered user, he can create and modify the nickname himself. The naming and use of user names and nicknames should abide by relevant laws and regulations and comply with network ethics. The user name and nickname must not contain any insults, threats, obscenities, verbal abuse, etc. that infringe on the legitimate rights and interests of others.
- 2) Once the user has successfully registered and becomes a member of BZEX, he will get the user name (user mailbox) and password, and be responsible for all activities and events that occur after logging in with this group of user name and password Legal responsibility directly or indirectly caused by the words, actions, etc.
- 3) The user is obliged to keep the BZEX account, user name and password, and SMS verification code properly, and the user will be fully responsible for the security of the user name and password. Any legal consequences caused by the leakage of the user name or password due to the user's reasons are the responsibility of the user. The site is not responsible for any property damage caused by the user's own leakage of this information. Since this site is a trading website, the login password, withdrawal password, transaction password, SMS password, etc. must not use the same password, otherwise there will be hidden security risks, and the relevant responsibility will be borne by the user himself.

- 2. Users have the right to obtain the rewards given by BZEX after posting information and other contributions in accordance with the relevant regulations of the website;
- 3. The user has the right to modify all the modifiable information in his personal account, choose the nickname and enter the introductory text, and decide whether to provide the content that is not required;
- 4. The user has the right to participate in the BZEX community and publish articles and opinions that comply with national laws and regulations and comply with the BZEX community rules;
- 5. Users have the right to receive rewards (such as community credits, badges, etc.) given by BZEX according to the relevant regulations of the website;
- 6. The user has the right to participate in various online and offline activities provided by the BZEX organization;
- 7. The user has the right to enjoy other services provided by BZEX in accordance with the provisions of the BZEX website.

Six, user obligations

- 1. Users can publish evaluation information on commodities or trading services on the BZEX platform, and can appropriately modify and delete them, but they have to use this site to endanger national security and disclose state secrets, and must not violate national social collectives and citizens The legal rights and interests of this website shall not be used to create, copy and disseminate the following information:
- 1) Oppose the basic principles stipulated in the Constitution, inciting, resisting, or undermining the implementation of the Constitution, laws and administrative regulations;
- 2) Inciting subversion of state power, overthrowing the socialist system, inciting and splitting the country, and undermining national unity;
- 3) Damage the national honor and interests;
- 4) Incite ethnic hatred, ethnic discrimination, and undermine ethnic unity;
- 5) Anything that includes discrimination against race, sex, religion, geographical content, etc.;

- 6) Fabricating or distorting facts, spreading rumors and disturbing social order;
- 7) Promote feudal superstition, cult, obscenity, pornography, gambling, violence, murder, terror, and abet crimes:
- 8) Those who openly insult others or fabricate facts to slander others, or carry out other malicious attacks:
- 9) Damage the credibility of state organs;
- 10) Other violations of the Constitution and laws and administrative regulations.
- 11) Conducting commercial advertising
- 2. Users are not allowed to maliciously register BZEX website account by any means, including but not limited to multiple account registration for the purpose of making profits, hype, cashing, winning, etc. Users must not misappropriate other user accounts. If the user violates the above regulations, BZEX has the right to take all necessary measures directly, including but not limited to suspending or sealing up the user's account, canceling the benefits obtained from violations, or even prosecuting the user's legal responsibility through litigation.
- 3. It is forbidden for users to use any form of BZEX network as a place, platform or medium for engaging in various illegal activities. Without the authorization or permission of BZEX, users shall not use the name of this site to engage in any commercial activities, nor shall they use BZEX as a venue, platform or medium for commercial activities in any form. 8. Legal jurisdiction and application

- 1. The conclusion, execution and interpretation of this agreement and the settlement of disputes shall be governed by the laws of mainland China.
- 2. BZEX keeps user identity information and records of large transactions and suspicious transactions, assists and cooperates with judicial and administrative law enforcement agencies in combating money laundering in accordance with law, and assists judicial authorities, customs, taxation and other departments to inquire, freeze and Deduct customer deposits.
- 3. BZEX complies with and implements the regulations of financial laws and regulations of various countries, the system of user identification, customer identity data and transaction record preservation, and the system of large and suspicious transaction reports.
- 4. According to the national anti-money laundering policy and the security of customer assets, the name of the sender must be the same as the real-name authentication name.
- 5. When users register, report loss of transaction password or fund password, they should provide and upload a copy of ID card, BZEX will identify and compare the ID card information provided by the user. BZEX has reasonable reasons to suspect that a user has the right to refuse to register or cancel an already registered account when registering with a false identity.

9. Supplementary Provisions
