



TERMS & CONDITIONS OF BQTX EXCHANGE

This Terms of Use Agreement (this “User Agreement”) is between you and the service operator, BQTX Exchange. By using any services provided by the BQTX Exchange website (<https://www.bqtexchange.com>) or BQTX Exchange affiliates (the “Services”), you agree that you have read, understood and agreed to all of the terms and conditions contained in this User Agreement, as well as our Privacy Policy. As this is a legally binding contract, please read through this User Agreement carefully and related notices before using any of the Services. By registering, accessing or using BQTX Exchange, you have agreed to the terms and conditions as laid out in this User Agreement. Should you disagree to this User Agreement, please proceed to initiate the account lock function (for existing users) and stop the usage of BQTX Exchange and any of the Services.

Through the usage and access of BQTX Exchange services, website its subpages or services affiliated with, originated by or arranged through, a registered member or website visitor accepts, without limitation. All of the terms and conditions of BQTX Exchange.

The original and only legally binding version of the Terms & Conditions of BQTX Exchange is in English. Translations of the Terms and Conditions into other languages are only indicative and should not be viewed as legal documents.

BQTX Exchange reserves the right to change these Terms & Conditions at any time. Change of these general conditions will occur by a standalone posting of a new and modified version of the Terms & Conditions of BQT Exchange on the bqtx.io website. Neither member or website user will be separately contacted or updated about the changes made to the Terms & Conditions of BQTX Exchange.

By using BQTX Exchange services, website its subpages or services affiliated with, originated by or arranged through, the Member agrees in advance that each use will be subject to the then applicable version of the Terms and Conditions of BQTX Exchange.

The Terms and Conditions apply to all Members, interested non-members, applicants and other individuals or entities visiting bqtx.io website or in any other form communicating or using services provided by BQTX Exchange, team members, shareholders, representatives, employees, and all other related parties.

1. AGREEMENT CONDITIONS

1.1. BQTX Exchange reserves the right to modify or change the terms and conditions of this User Agreement at any time and from time to time in its sole discretion. BQTX Exchange will provide notice of these changes by updating the revised User Agreement on the website. Any and all changes or modifications to the User Agreement will be effective concurrent with its publishing on the BQTX Exchange website. Your continued use of BQTX Exchange's services is shall act as the agreement to the terms and conditions of the amended User Agreement.

2. ELIGIBILITY

2.1. By registering to use a BQTX Exchange Account, you affirm that you are at least 18 years old and are an individual, legal person or other organization with full legal capacity to enter into this User Agreement between you and BQTX Exchange. If you are not, please discontinue use of the Services. In addition, BQTX Exchange shall have the right to close or lock your account in addition to filing claims against you and/or your legal guardian for damages related to your use of the BQTX Exchange.

3. PROHIBITION OF USE

3.1. By logging into or using BQTX Exchange and any of the Services, you acknowledge and affirm that you are not on any trade or economic sanctions lists, such as the United Nations Security Council Sanctions List and its equivalent. BQTX Exchange maintains the right to select its markets and jurisdictions to operate and may restrict or deny its services to certain countries. The content of this User Agreement shall not be excluded from the laws of the country under which the user belongs. BQTX Exchange demands that any users not in full compliance with this User Agreement refrain from accessing the BQTX Exchange and/or using any of the of the Services.

4. DESCRIPTION OF SERVICES

4.1. BQTX Exchange provides a platform for online peer-to-peer digital asset trading (crypto to crypto) for electronic currency such as digital tokens, cryptographic tokens or cryptographic currency. BQTX Exchange does not offer the ability to trade traditional fiat currencies on its platform and as such is not subjected to the strict regulations relating to such capabilities. BQTX Exchange functions as a trading platform provider and is not a buyer or seller in trades

conducted between traders. BQTX Exchange is also not a market maker. Traders must register and open an account with BQTX Exchange and deposit digital assets prior to beginning to trade. Traders may request the withdrawal of their digital assets, subject to any restrictions set forth in this User Agreement.

4.2. BQTX Exchange endeavors to ensure the accuracy of information posted on its website; however it cannot and does not guarantee the accuracy, suitability, reliability, completeness, performance or fitness for any particular purpose of the content on the website, and will not accept liability for any damage or loss that may result directly or indirectly from such content. Information on the BQTX Exchange website is subject to change without notice and is provided primarily to help facilitate users in reaching better-informed trading decisions. However, BQTX Exchange does not offer investment or advisory advice and accepts no responsibility for the use or interpretation of information stated on its website or other communication mediums. All users of BQTX Exchange must understand that there are significant risks involved in trading. BQTX Exchange encourages all users to apply prudence and trade responsibly within their own means.

4.3. While BQTX Exchange emphasizes platform security to safeguard the continuity and security of the Services (announcements will be made in event of downtime/maintenance), it will not be accountable for acts of God, malicious targeted hacking, terrorist attacks, and other unforeseen circumstances. BQTX Exchange reserves the right to cancel, rollback or block transactions of all types on its platform in the event of irregular transactions. BQTX Exchange will never solicit passwords from its users nor will it ask users to transfer funds that are not listed on its trading platform. The internet is full of cybercriminals intent on defrauding and stealing personal information of persons such as users and all users are encouraged to be vigilant regarding promotional offers or other target communication that could lead such occurrences. While the above list is non-exhaustive, you agree that BQTX Exchange will not be held responsible for any losses resulting from the situations listed above.

4.4. By using BQTX Exchange and any of the Services, you affirm that all information provided to BQTX Exchange in connection with this User Agreement is true, accurate and complete.

5. REGISTRATION

5.1. All users must register for a BQTX Exchange Account before using the website. To register for an account, you are required to provide your real name, email address, and password, as well as agree to accept this User Agreement and Privacy Policy. Under certain circumstances, and at our sole discretion, we may refuse to open an account for you.

6. USER IDENTITY VERIFICATION

6.1. By registering an account on BQTX Exchange, you agree to share personal information requested for the purposes of identity verification. Such information shall be used for the detection of money laundering, terrorist financing, fraud and other financial crimes on the

BQTX Exchange platform. In addition to providing this information, to ensure compliance with global industry standards for data retention, you agree that we may retain such information for the lifetime of your account plus five years beyond the date your account is closed. You also authorize us to make inquiries, either directly or through third parties, that BQT may deem required to verify your identity or to protect you and/or us against financial crimes such as fraud.

6.2. The Identity Verification information we request may include but is not limited to, your name, email address, contact information, phone number, username, and government-issued ID. In providing this required information, you confirm that it is accurate and authentic. After registration, you must covenant that information shall remain truthful, complete and updated in a timely manner with any changes. If there is any reasonable doubt that any information provided by you is incorrect, untruthful, outdated or incomplete, BQTX Exchange shall have the right to send you a notice to demand corrections, remove relevant information directly and, as the case may be, terminate all or part of BQTX Exchange Service to you. You shall be solely and completely responsible for any loss or expenses incurred during the use of BQTX Exchange Service if you cannot be contacted through the contact information provided. You hereby acknowledge and agree that you have the obligation to keep all information provided current and accurate.

7. ACCOUNT USAGE REQUIREMENTS

7.1. Only the person whose name is registered on the BQTX Exchange account may use the account. BQTX Exchange reserves the right to suspend, freeze or close accounts that are used by persons other than the persons whose names they are registered under. BQTX Exchange will not be liable or legally responsible for such accounts.

8. ACCOUNT SECURITY

8.1. BQTX Exchange focuses on maintaining the safety of those user funds entrusted to us and has implemented industry standard protections for our platform. Nevertheless, there are account-level risks that are created by individual user actions. We request that you recognize the need to independently take safety precautions to protect your own account and personal information.

8.2. You shall be solely responsible for the safekeeping of your BQTX Exchange account information and password, and you shall be accountable for all activities under your log-in email, BQTX Exchange account and password (including but not limited to information disclosure, information posting, consent to or submission of various rules and agreements by clicking on the website, online renewal of agreement, etc.).

8.3. You hereby agree that:

8.3.1. you will notify BQTX Exchange immediately if you are aware of any unauthorized use of your BQTX Exchange account and password or any other potential security issue;

8.3.2. you will strictly follow the security, authentication, dealing, charging, withdrawal

mechanism or other procedures of the BQT Website and the Services; and

8.3.3. you will log out properly from the website at the completion of your session. by taking in the proper manner at the end of every visit.

8.4. BQTX Exchange will not be accountable for any loss or consequences caused by your failure to comply with the above account security provision.

9. DISPUTE RESOLUTION

9.1. BQTX Exchange reserves the right to settle issues and disputes in whichever manner and forum it deems suitable. Some issues include infringement of others' rights, violation of laws and regulations, abnormal trades and other issues not explicitly mentioned in this User Agreement. Users agree to bear the costs arising from the process of dispute resolution.

10. GUIDELINES FOR USAGE OF SERVICES ON BQTX EXCHANGE

10.1. You hereby agree to observe the following covenants during your use of the Services on BQTX Exchange:

10.1.1. All the activities that you perform during the use of the Services will be in compliance with the requirements of applicable laws, regulations, as well as the guidelines of BQTX Exchange,

10.1.2. will not be in violation of public interests, public ethics or others' legitimate interests,

10.1.3. will not be used to evade lawful taxes or fees and will not violate this User Agreement or relevant rules.

10.2. If you violate the foregoing covenants, you shall solely assume all of the legal consequences related to such violation and shall indemnify BQTX Exchange from all actions, claims, or costs arising from such violation. You will not use any data or information displayed on the website for commercial purposes without the prior written consent of BQTX Exchange. You shall use the site in accordance with this User Agreement, and shall refrain from any acts of unfair competition or any actions that may interfere with the normal operation of BQTX Exchange. Examples of such prohibited acts include, but are not limited to:

10.2.1. using a device, software or subroutine to interfere with the site

10.2.3. executing malicious sales or purchases on the market

10.3. By using the BQTX Exchange Service, you agree that BQTX Exchange shall have the right to determine in its sole discretion whether you have violated any of the above covenants and take actions to apply relevant rules without receiving your consent or giving prior notice to you. Examples of such actions include, but are not limited to:

10.3.1. block and close order requests

10.3.2. freezing your account

10.3.3. reporting the incident to authorities

10.3.4. publishing the alleged violations and actions that have been taken

10.3.5. deleting any information you published that is in violation

10.4. If your alleged violation causes any losses to a third party, you shall solely undertake all

the legal liabilities in your own name and hold BQTX Exchange harmless from any loss, fine or extra expenses. If due to any alleged violation BQTX Exchange incurs any losses, is claimed by any third party for compensation or suffers any penalty or other legal consequences imposed by any administrative authorities, you shall indemnify BQTX Exchange against any losses and expenses caused thereby, including reasonable attorney's fees.

11. SERVICE FEES

11.1. BQTX Exchange reserves the rights to levy service fees on users who use its services. It is in the sole discretion of BQTX Exchange to adjust the service fees charged to users using the Services.

12. LIABILITY: PROVISION OF SERVICE

12.1. BQTX Exchange provides the Services in an "as is" and "commercially available" condition and does not offer any form of warranty with regard to the Service's reliability, stability, accuracy and completeness of the technology involved. BQTX Exchange serves merely as a venue for transactions where coin-related information can be attained and coin-related transactions can be conducted. BQTX Exchange cannot control the quality, security or legality of the coin involved in any transaction, the truthfulness of the transaction information, or capacity of the parties to any transaction to perform their obligations under the rules. You must carefully consider the associated investment risks, legal status and validity of the transaction information and investment decisions prior to your use of the BQTX Exchange Services provided.

13. LIMITATION OF LIABILITY

13.1. You acknowledge and agree that BQTX Exchange shall not be liable for any losses caused by any of the following events, including but not limited to:

13.1.1 Losses of profits, goodwill, usage or data or any other intangible losses

13.1.2 Use or failure to use BQTX Exchange Service

13.1.3 Unauthorized use of your account or unauthorized alteration of your data by third parties

13.1.4 Your misunderstanding of BQTX Exchange Service

13.1.5 Any other losses related to BQTX Exchange Service which are not directly attributable to BQTX Exchange

13.2 In no event shall BQTX Exchange be liable for any failure or delay of service resulting from regular network maintenance or external factors such as power failure, natural disaster, service provider-side problems or governmental acts.

14. INDEMNIFICATION

14.1. You agree to indemnify and hold harmless BQTX Exchange, its affiliates, contractors, licensors, and their respective directors, officers, employees and agents from and against any claims and damages (including attorneys' fees, fines or penalties imposed by any regulatory authority) arising out of your breach or our enforcement of this Agreement. The above-mentioned indemnity shall also apply to any violation of any applicable law, regulation, or rights of any third party during your use of the Services.

15. TERMINATION OF AGREEMENT

15.1. BQTX Exchange has the right to immediately suspend your account (and any accounts beneficially owned by related entities or affiliates), freeze or lock the funds in all such accounts, and suspend your access to BQT Exchange if we suspect any such accounts to be in violation of this User Agreement, AML/CTF acts or any applicable laws & regulations. BQTX Exchange shall have the right to keep and use the transaction data or other information related to such accounts. The above account controls may also be applied in the following cases:

15.1.1. The account is subject to a governmental proceeding, criminal investigation or other pending litigation;

15.1.2. We detect unusual activity in the account;

15.1.3. We detect unauthorized access to the account; or

15.1.4. We are required to do so by court order or command by a regulatory/government authority.

15.2. In case of any of the following events, BQTX Exchange shall have the right to terminate this User Agreement by canceling your account, and shall have the right to permanently freeze (cancel) the authorizations of your account on BQTX Exchange and withdraw the corresponding BQTX Exchange account thereof:

15.2.1. after BQTX Exchange terminates services to you;

15.2.2. you allegedly register or register in any other person's name as BQTX Exchange user again, directly or indirectly;

15.2.3. the main content of user's information that you have provided is untruthful, inaccurate, outdated or incomplete;

15.2.4. when this User Agreement (including the rules) is amended, you expressly state and notify BQTX Exchange of your unwillingness to accept the amended service agreement; and

15.2.5. any other circumstances where BQTX Exchange, in its sole discretion, feels such termination is warranted.

15.3. Should the account be terminated, the account and transactional information required for meeting data retention standards will be securely stored for five years. In addition, if a transaction is incomplete during the account termination process, BQTX Exchange shall have the right to notify your counterparty of the situation at that time.

16. REMAINING FUNDS AFTER ACCOUNT TERMINATION (STANDARD)

16.1. Upon termination of the account, any remaining balance (which includes charges and liabilities owed to BQT Exchange) on the account will be payable at once to BQTX Exchange. Upon payment of all outstanding charges to BQT Exchange (if any), the user will have five business days to withdraw all funds from the account.

17. REMAINING FUNDS AFTER ACCOUNT TERMINATION (FRAUD/AML/VIOLATION OF TERMS)

17.1. BQTX Exchange maintains full custody of the funds and user data/information that may be turned over to applicable authorities in the event of account suspension/closure resulting from fraud investigations, AML investigations or violation of BQTX Exchange's Terms (eg. trading on BQTX Exchange from a sanctioned country).

18. COMPLIANCE WITH LOCAL LAWS

18.1. The user is responsible to abide by local laws related to the use of BQTX Exchange in their local jurisdiction including but not limited to all types of taxation, withholding, collection, reporting and remittance to their appropriate tax authorities. All users of BQTX Exchange and any of the Services represent and warrant that the source of their funds come from a legitimate manner and are not derived from illegal activities. BQTX Exchange actively cooperates with law enforcement authorities globally and will not hesitate to seize, freeze, terminate the account and funds of users which are flagged out or investigated by legal decree.

19. INDEMNITY AND DISCLAIMER

19.1. You agree to indemnify BQTX Exchange and its entirety of affiliates and hold them harmless from and against all third party claims except BQTX Exchange's breach of these Terms. As mentioned in the description of services, BQTX Exchange tries its best to maintain the data integrity on its site but does not guarantee the information and services provided in its platform. BQTX Exchange will not be liable for errors arising from the use of its services.
